Occidental Community Services District Meeting Minutes September 10, 2019

Call to order at 7:02pm.

Public Comment: None.

Consent Calendar

Approval of minutes for August 7, 2019 was made by Gonnella/Brown, VOTE: 5-0

Warrants were approved with the addition of \$500 to the Howard Station payment for weed eating by Gonnella/Brown, VOTE: 5-0

Direct Charges were approved for tax year 2019/20 by Brown/Gonnella, VOTE: 5-0

Public Hearing opened at 7:06pm. President Lunardi explained the appropriation limit and what it does. No further discussion. Discussion took place regarding Exhibit A. Typo to be corrected on page 8 to reflect OCSD rather than Valley of the Moon. Director Brown asked about hardship clauses. Director McNeal asked if parcels can be modified. It was stated that the exhibit shows the ceiling, and that the parcels can change subject to annual increase. There is no sunset clause. Bill Adams went over the tax roll process and public hearing process for the future to bring forth any annual adjustment. Denny Rosatti discussed polling, stating 80.7% polled very favorable for the tax increase. 12% not favorable, and 7-8% in the middle. The poll was based on a \$200 tax, and 5% were polled. The polling also maintained an 80% level of people currently having an extremely high or very satisfied position about the fire department. There were zero responses that stated anyone was not satisfied. The public hearing closed at 7:46pm.

Motion to approve Resolution 2019-03 adopting the appropriation limit as the County of Sonoma calculated was approved by **Brown/Martin**, **VOTE 5-0**. Public Hearing closed at 7:07pm.

Public Hearing reopened at 7:07pm. There were a few general questions regarding water in regards to line items and how revenue was determined.

Discussion took place regarding pricing and the Chief was asked to give it consideration. Clerk was asked to put Chief Lunardi's truck on the bills for next month.

Chief Lunardi also reported a fire on Coleman Valley Road recently. President Lunardi was first on scene and the fire was controlled very quickly.
